On 07/02/07 at 2037 hours, I, Officer Medeiros #215 was dispatched to 4150 Kirkpatrick Ln. reference a meet complainant. The complainant in the lobby of the police station had questions and wanted to speak to an officer about domestic violence. Upon arrival, I contacted the R/P, Aasiya Hassan. Aasiya stated that she and her husband, Muzzammil live in Buffalo, NY and they are here on vacation visiting relatives. Aasiya stated that she had a protective order placed on Muzzammil due to his violent behavior in the past. Aasiya stated that the order does not prohibit Muzzammil from being around her. Aasiya then stated that the order states that he can not touch or threaten her in a violent manner. Aasiya then asked what could be done here in Texas if he violates the order. I then told Aasiya that if Muzzammil violates the order in Texas he could still be prosecuted. I then asked Aasiya if Muzzammil violated the order or assaulted her since they arrived in Texas. Aasiya then told me that last Friday they had an argument where Muzzammil got physical. Aasiya then told me that the argument was over the GPS tracker they brought with them to use in Texas. Aasiya stated that Muzzammil was going fishing with his family and she wanted to use the GPS tracker to go site seeing. When Muzzammil told her no, she made the comment that she should have known better than to even ask. Aasiya stated that her comment upset Muzzammil and he grabbed her arm and told her to apologize. When Aasiya refused to apologize Muzzammil held her by the arm and said he would until she apologized. Aasiya stated that she was able to break free and go to another room. Aasiya stated at that point the incident was over. After Aasiya told me the details of the incident she showed me where Muzzammil held her arm. I saw bruising around her upper left arm. I then explained to Aasiya in Texas anytime an assault from family violence is reported to us we are required to file a report. Aasiya then asked if she could speak to her brother-in-law. While Aasiya was talking to her brother-in-law I started copying down their information from a copy of the protective order issued in New York. When Aasiya saw what I was doing she questioned me. I explained to Aasiya that I was just copying down Muzzammil and her information for my report. Aasiya got very offended and stopped cooperating with my interview. Aasiya then refused to give me anymore information and walked out of the police department. Aasiya did tell me as she was leaving that she is unsure if she wants a report filed and if she decides to file one she would come back at a later time. At that point Aasiya and her brother-in-law left.

On 7-06-07, I responded to the PD on a walk in report of an Assault. I contacted the complainant/victim, Husiya Hassan O/F/6-13-71. Mrs. Hassan advised that on 06-30-07 her husband, Muzzammil Hassan, Assaulted her resulting in pain and bruising. The assault occurred at 6088 Diana Ln Flowermound, TX

Mrs. Hassan advised that on 06-30-07 Mr. Hassan and she had a verbal argument. After the argument, Mr. Hassan coerced her in to a bedroom. Once in the bedroom, Mr. Hassan pushed her down onto the bed, sat on her chest and pinned her arms and legs down. This was done to "make" her listen to him. Mrs. Hassan told Mr. Hassan several times that he was hurting her and to get off her. He refused. Mrs. Hassan received bruises to her left arm and calf as a result of this assault. The bruises were photographed and entered as evidence.

Mrs. Hassan provided me with a copy of a protective order from the family court of the State of New York, Erie County. The order was entered on March 26, 2007. Mr. Hassan has had 3 other protective orders issued prior to that date all in a 1 month period, March 2007. The protective order allowed Mr. and Mrs. Hassan to cohabit, but ordered him to refrain from committing any criminal offense against Mrs. Hassan.
